# 2.3 Other Hazards

AquaClean may be weakly irritant to eyes and mucosa in random cases. Avoid contact with eyes and mucosa. The concentrate of AquaClean is classified as 'harmful to aquatic organisms'. <u>The diluted</u> working solution (1:200) is appropriately diluted in order to be disposed via canalisation.

# 7.3. Specific end use(s):

#### General Application:

AquaClean is indicated for application in waterbaths and waterreservoirs inside cell culture incubators. It protects the water within these containers from microbial contamination. The protection prevails for up to four weeks. The blue colour-indicator signals a beginning contamination by decolourization of the water.

#### Application in waterreservoirs inside cell culture incubators.

AquaClean is suited to be applied in the waterreservoirs inside cell culture incubators. As the active ingredients of AquaClean are non-volatile there is no danger for the cell cultures stored inside the incubator to be invaded by the disinfectant via air.
